THE YWCA SUPPORT SERVICES AND HOUSING DEPARTMENTS PROVIDE AN INTEGRATED CONTINUUM OF CRISIS RESPONSE AND PREVENTION SERVICES FOR SEXUAL ASSAULT, DOMESTIC VIOLENCE AND HUMAN TRAFFICKING SURVIVORS, WITH 24-HOUR CRISIS LINES AND CRISIS INTERVENTION, SHELTER, TRANSITIONAL, AND SUPPORTIVE HOUSING PROGRAMMING, COUNSELING, ADVOCACY, LEGAL SERVICES, AND COMMUNITY EDUCATION. YWCA GGSV BELIEVES THAT GENDER INEQUALITY, RACISM, AND VIOLENCE ARE MUTUALLY COMPOUNDING AND FUELED BY UNTREATED TRAUMA, UNCONSCIOUS BELIEFS, AND SYSTEMIC INEQUALITY. THE MISSION FRAMEWORK OF YWCA GGSV ALLOWS FOR THE ADOPTION OF CAPACITY BUILDING AND SYSTEMS CHANGE APPROACHES TO ELIMINATE RACISM AND EMPOWER WOMEN, AS WELL AS PROVIDE NEEDED CRISIS INTERVENTION SERVICES. TO ENSURE SYSTEMS CHANGE, YWCA GGSV PROVIDES PREVENTION AND COMMUNITY
